By virtue of Proclamation No. 115-A, signed by then-President Ferdinand E. Marcos, and Proclamation No. 360 in 1986, the month of March was declared as "Fire Prevention Month" or "Burn Prevention Month."

The fire prevention month campaign, according to the measure, promotes "safety consciousness among our people every day of the year as a positive preventive approach to a problem that can be solved by more caution, vigilance, sobriety, the exercise of common sense, and respect for the law."

Incidents of fire are very much prevalent as the summer season enters the frame, and BFP aims to push for campaigns that will educate people to be more careful and educated to prevent any untoward incidents. IECEP, being an organization with professionals who play a very vital role on Fire Safety and Protection in the country, should have a significant role on this campaign.

As such, all Chapters along with the IECEP Building Electronics and Auxiliary Systems Society (BEASS) are hereby enjoined to visit the nearest Bureau of Fire Protection (BFP) regional/city/municipality office within their locality and offer ACTIVE participation on BFP events lined-up in support of the Fire Prevention Month this March 2023. Presence in motorcades, tree planting, and seminars/workshops on the role of Electronics Engineers in Fire Safety and Protection are among the set of activities IECEP could offer to BFP.

Photo and Video documentations with Live Streaming on the Chapter FB Pages are highly encouraged, if applicable, to highlight the IECEP-wide support for such activities. In addition, Chapters are requested to share online collaterals through their respective social media channels either from IECEP National or from the official pages of concerned agencies. Physical Banners, as far as practicable, are likewise to be displayed, in your respective offices, if applicable.
