ADMINISTRATIVE ORDER NO. 2022-06

**FOR: GENERAL MEMBERSHIP
LOCAL AND FOREIGN CHAPTERS
NATIONAL SECRETARIAT**

SUBJECT: IMPOSITION OF MORATORIUM ON THE COLLECTION OF MEMBERSHIP BACK-DUES AND ARREARS

DATE: 13 JULY 2022

In view of the APPROVED NEW RATES OF MEMBERSHIP DUES AND RELATED FEES, implementation of which shall commence on 01 August 2022, the following guidance is hereby provided.

- To encourage members whose renewals are already due, i.e. with expired membership, IECEP shall impose a moratorium on the collection of back-dues and arrears for three (3) months, from 01 August 2022 to 30 November 2022; subject to extension as may be appropriate.
- From 01 August 2022, chapters are hereby instructed to accept membership renewals, waiving back-dues and arrears, and to collect solely the membership due, based on new rates, as provided.
- After the moratorium, collection of back-dues and arrears shall apply based on the rules on prescribed maximum period (Board Resolution No. 2009-03), i.e. seven (7) years, adopting rates for the covered year, i.e. old rates until 2021; new rates beginning 2022.
- It is clarified that remittances due the National, for renewals processed by the Chapter from 01 August 2022, until the moratorium's validity, shall only cover the membership dues and fees for 2022 - 2025, without back-dues nor arrears.
- It is further clarified that Associate or Regular Members intending to avail of the moratorium, if eligible, may likewise apply for Life Membership.
- The Membership, Organizational Development and Chapters Committee (MODCC) and the Finance Committee are hereby instructed to implement this Order.
