#### MANAGEMENT OF DONATIONS, CONTRIBUTIONS AND PLEDGES FOR IECEP HOME

**WHEREAS**, Article 7, of the Institute's Articles of Incorporation (Aol), provides basis as to the expenditure program for fees, charges, contributions or donations for the intended purpose, which, for this exercise is made in view of the IECEP Home Project;

**WHEREAS**, as carried out in the Special General Membership (SGM) Meeting conducted online last 01 November 2021, the action of the Board of Directors stipulated in BR 2021 - 029, on the acquisition of real property for IECEP Home, was approved;

**WHEREAS**, as there is a need to raise funds relative to the IECEP Home Project, for the completion of its acquisition and other related improvements, Donations, Contributions and Pledges (DCP) made by interested parties, including members, chapters and institutions, among others, hereafter, for the same purpose, shall be effectively managed by the Ways and Means Committee;

**WHEREAS**, the Ways and Means Committee shall engage relevant stakeholders as deemed appropriate by its Chair, for the effective implementation of its functions, including undertaking formal agreements as may be necessary;

**WHEREAS**, the National Secretariat shall provide support for the implementation of sub-programs, in relation to matters administrative in nature, including recording of DCPs, issuance of receipts, and others as may be assigned;

**WHEREAS**, proceeds, monetary in nature, from the DCPs shall be ultimately attributed to the IECEP Home Bank Account, BPI 2561 0118 53, through Digital Payment Platforms, Direct Deposit, or other equivalent means of Fund Transfer, subject to usual accounting and auditing;

**WHEREAS**, in consideration of the incentives for donors, contributors and pledgors as may be legally allowed, an alternative bank account may likewise be designated for utilization on case-to-case basis, subject to the approval of a collaborative framework detailing the process, and for the subsequent issuance of statement of account billing the same for settlement to the above-stated account;

**WHEREAS**, operational expenses of the Ways and Means Committee, including the production of IECEP Merchandise and tokens in exchange of DCPs, shall be chargeable against the above-stated account;

**RESOLVED**, as it is hereby **RESOLVED**, that the Management of DCPs shall be carried out by the Ways and Means Committee, supported by the National Secretariat.

**RESOLVED FURTHER**, that IECEP Home Bank Account shall be the standard beneficiary account of the DCPs, unless otherwise requested and approved.
