RESOLUTION NO. 2022-033

APPROVAL OF AUTHORITY TO PRINT MEMBERSHIP ID DURING RENEWALS FOR IECEP NCR-NORTHEAST CHAPTER

WHEREAS, IECEP, Inc., aims to streamline and simplify the current membership process to enhance membership transactions and to commit a measurable service level mechanism acceptable for the National Secretariat, the Chapters and the General Membership;

WHEREAS, IECEP, Inc., recognizes the need for some chapters to be given the authority to print membership IDs during the renewal of membership of their members to further shorten the committed service level for issuance of the newly-designed one-time print membership IDs;

WHEREAS, IECEP Inc., shall ensure that the Authority to Print privilege given to a chapter would follow security mechanisms, processes, procedures and workflows that will safeguard the integrity of the membership renewal process;

WHEREAS, IECEP Inc., shall impose a Php 10,000.00 Performance Bond for Chapters that will be granted Authority to Print, which shall be fully refundable from the National Treasury upon cessation of the privilege given to them;

WHEREAS, the Authority to Print privilege given to a chapter shall further complement the 4-Step Streamlined Membership Process including the 1-time printing and deployment of the newly designed IDs;

WHEREAS, IECEP, Inc., aims to give Authority to Print Privileges to Chapters that satisfy the requirements stated and defined on Board Resolution Number 2022-007 and its Implementing Rules and Regulations;

WHEREAS, IECEP NCR Northeast Chapter applied for accreditation and they were able to satisfy the minimum requirements of IECEP, Inc. through the recommendation of the IECEP Memberships, Organizational Development and Chapters Committee (MODCC);

NOW, THEREFORE RESOLVED, as it is hereby resolved, that IECEP NCR Northeast Chapter is now approved and given the Authority to Print Permanent Membership IDs for Membership Renewals at their Chapter jurisdiction.

RESOLVED FURTHER, that this approved privilege be published in the Official Website and furnished to all Accredited Chapters, the National Specialization/Specialty Societies and the General Membership for guidance and reference of all concerned; and that these shall be effective immediately upon the release of this resolution.
