**RESOLUTION NO. 2022-007**

**ESTABLISHMENT OF THE AUTHORITY TO PRINT IDS FOR THE MEMBERSHIP RENEWALS AT THE CHAPTERS**

**WHEREAS**, IECEP, Inc., aims to streamline and simplify the current membership process to enhance membership transactions and to commit a measurable service level mechanism acceptable for the National Secretariat, the Chapters and the General Membership;

**WHEREAS**, IECEP, Inc., recognizes the need for some chapters to be given the authority to print membership IDs during the renewal of membership of their members to further shorten the committed service level for issuance of the newly-designed one-time print membership IDs;

**WHEREAS**, IECEP Inc., shall ensure that the Authority to Print privilege given to a chapter would follow security mechanisms, processes, procedures and workflows that will safeguard the integrity of the membership renewal process;

**WHEREAS**, IECEP Inc., shall impose a Php 10,000.00 Performance Bond for Chapters that will be granted Authority to Print, which shall be fully refundable from the National Treasury upon cessation of the privilege given to them;

**WHEREAS**, the Authority to Print privilege given to a chapter shall further complement the 4-Step Streamlined Membership Process including the 1-time printing and deployment of the newly designed IDs;

**NOW, THEREFORE RESOLVED**, as it is hereby resolved, that the Authority to Print IDs for the Membership Renewals at the Chapter shall now be permitted for chapters upon the approval of their application to the National Board and that the Membership, Organizational Development and Chapters Committee of the Institute be empowered to prescribe and create the implementing guidelines as appropriate and necessary;

**RESOLVED FURTHER**, that these standardized processes and corresponding guidelines be published in the Official Website and furnished to Accredited Chapters for guidance and reference of all concerned; and that these shall be effective immediately upon the release of this resolution and the implementing guidelines.
